學程辦法 Regulations	依據「國立中興大學生技產業創新研發與管理博士學位學程候選人資格考核實施辦法」第二條規定，「本學位博士生應於第三學年結束前，提出及完成博士學位候選人資格考核…。」 According to Article 2 of the Regulations for the Regulations for the Qualifying Examination of Doctoral Degree Candidates, Doctoral Program in Biotechnology Industrial Management and Innovation, College of Life Sciences, National Chung Hsing University, doctoral students must submit and complete the qualifying examination for doctoral candidacy by the end of their third year.
考試委員 資格 Eligibility Criteria for Examination Committee Members	依據本校「國立中興大學博士班學位考試細則」第三條規定「考試委員應對博士學位候選人之研究領域有專門研究，並應具有下列資格之一： 一、現任或曾任教授、副教授。 二、中央研究院院士、現任或曾任中央研究院研究員、副研究員。 三、獲有博士學位，且在學術上著有成就。 四、研究領域屬於稀少性或特殊性學科，且在學術或專業上著有成就。 前項第三款、第四款資格之認定基準，由辦理學位授予之各系、所、院務會議或學位學程事務會議定之。」 (※備註：請同時參閱本校「國立中興大學博士生通過博士候選人資格考核通知書」二之規定。) Pursuant to Article 3 of the Regulations for Doctoral Degree Examinations of National Chung Hsing University, members of the examination committee shall possess specialized research expertise in the candidate's field and shall satisfy one of the following qualifications: 1. Currently hold or have formerly held the academic rank of Professor or Associate Professor. 2. Be an Academician of Academia Sinica, or currently hold or have formerly held the office of Research Fellow or Associate Research Fellow at Academia Sinica. 3. Hold a doctoral degree and have demonstrated distinguished academic accomplishments. 4. Be engaged in a discipline that is rare or specialized within the research field and have demonstrated notable academic or professional achievements. The criteria for the recognition of qualifications under items 3 and 4 above shall be established by the DPBIMI meeting that has authority over the conferral of the degree. (For supplementary provisions, refer to Article 2 of the Notification for PhD Students Passing Doctoral Candidate Evaluation, NCHU.)
